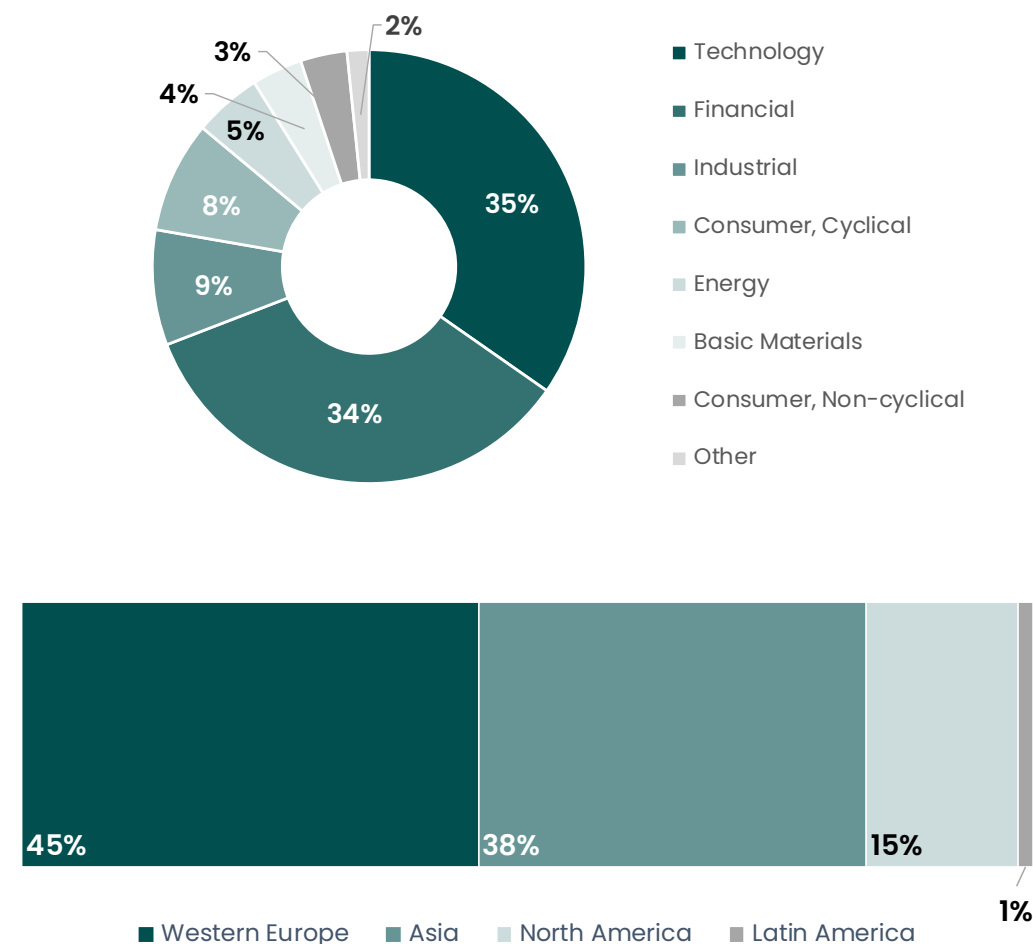

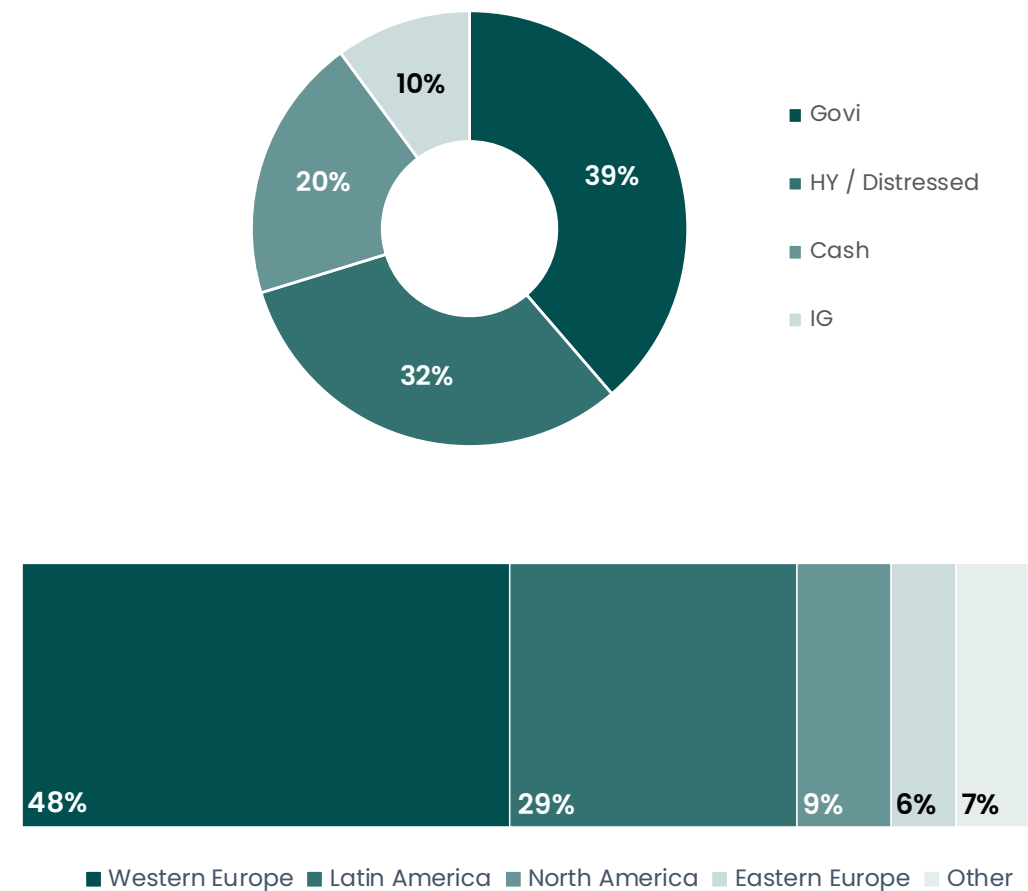

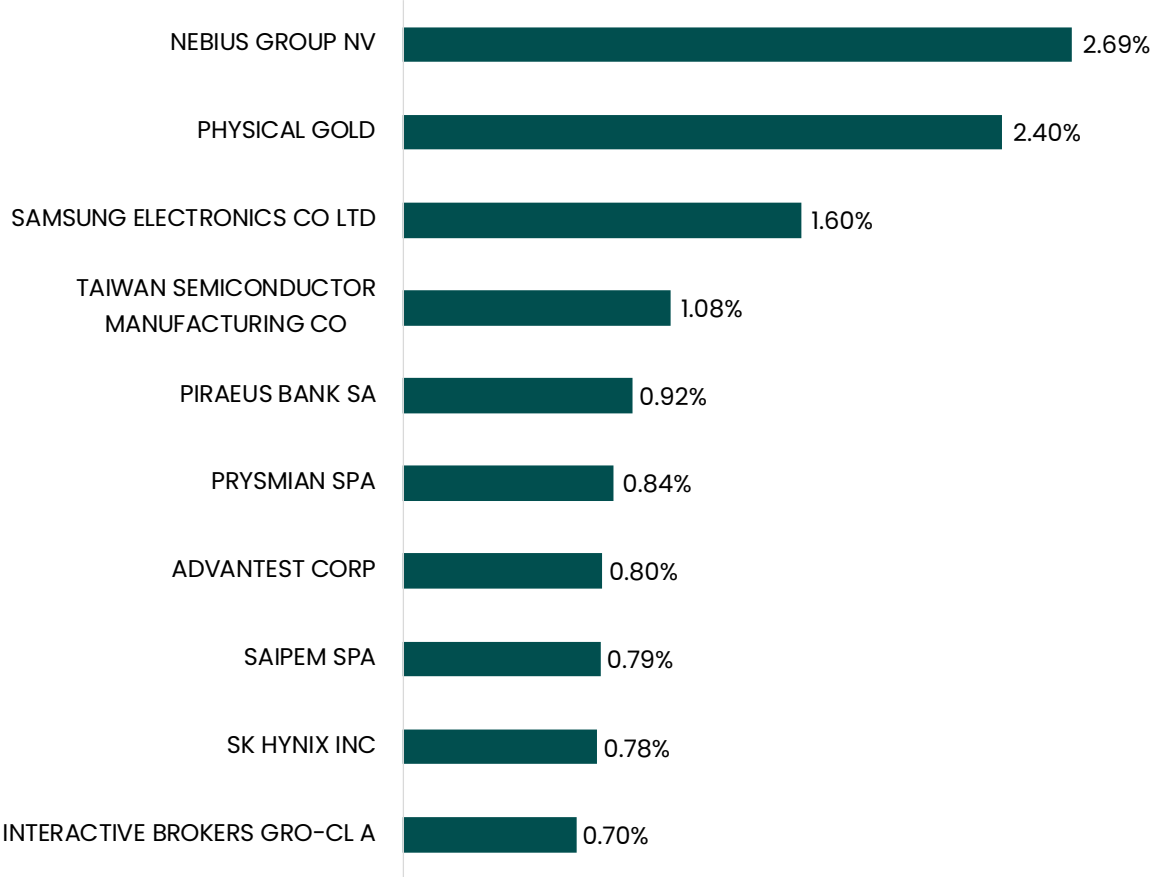

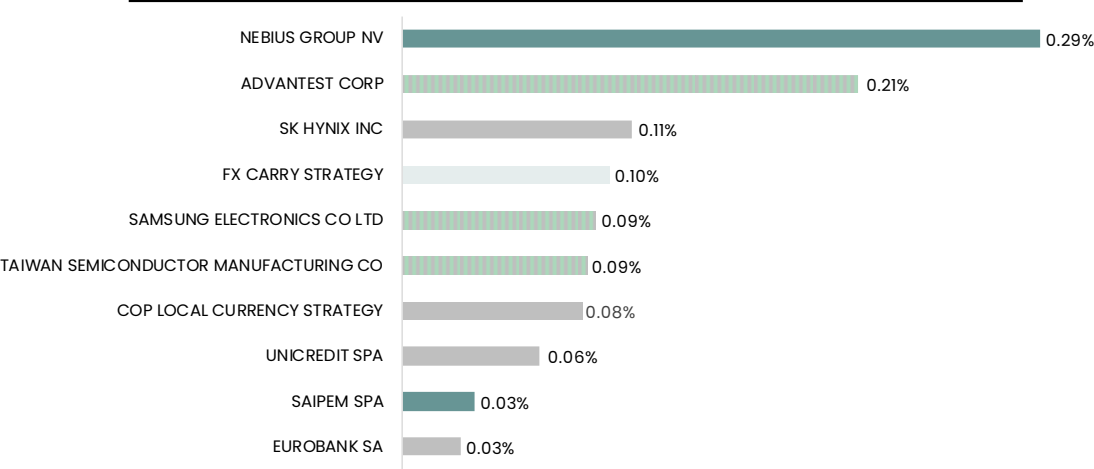
Top Contributors 1 Year Rolling



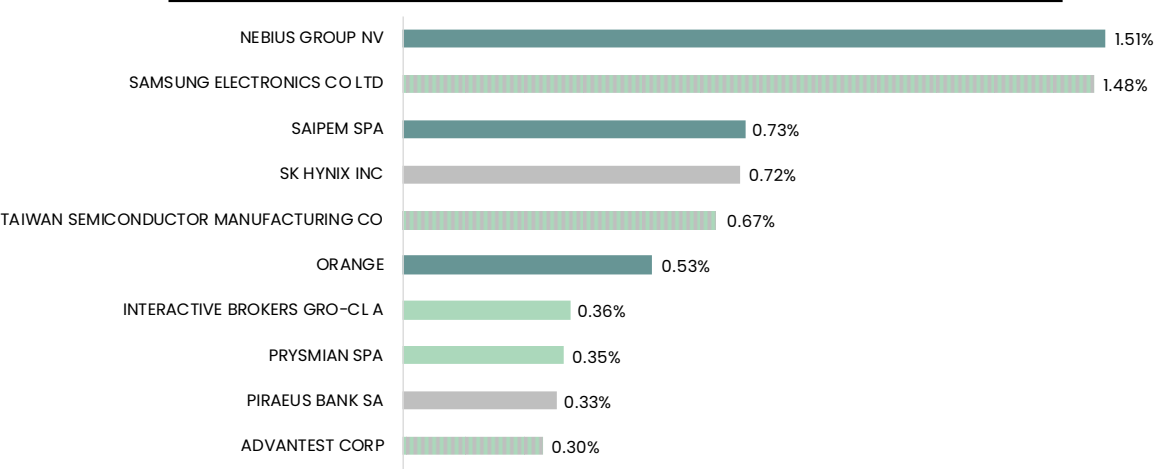

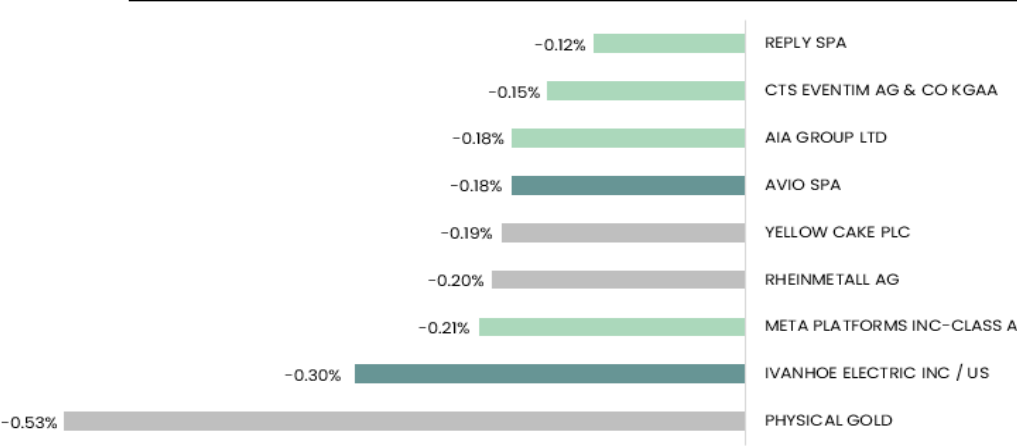
Top Contributors MTD



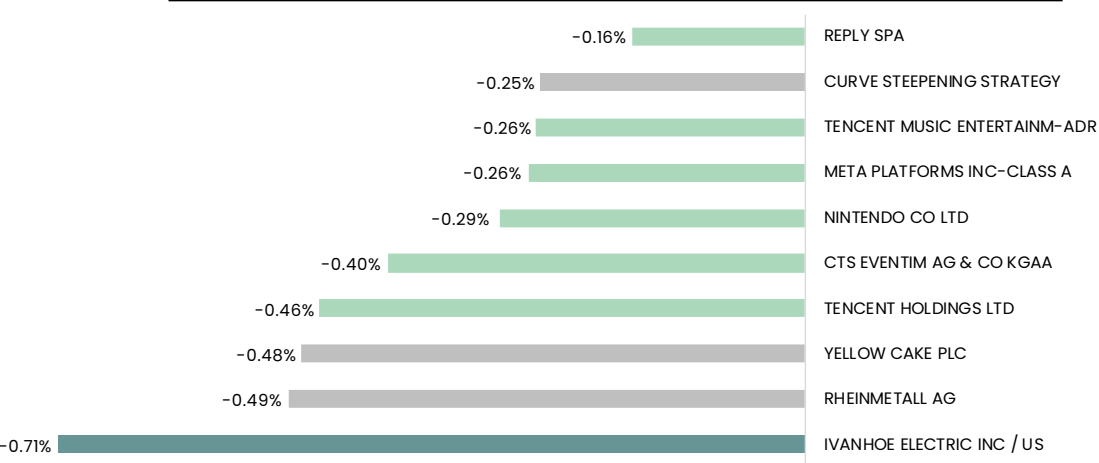
Top Contributors YTD

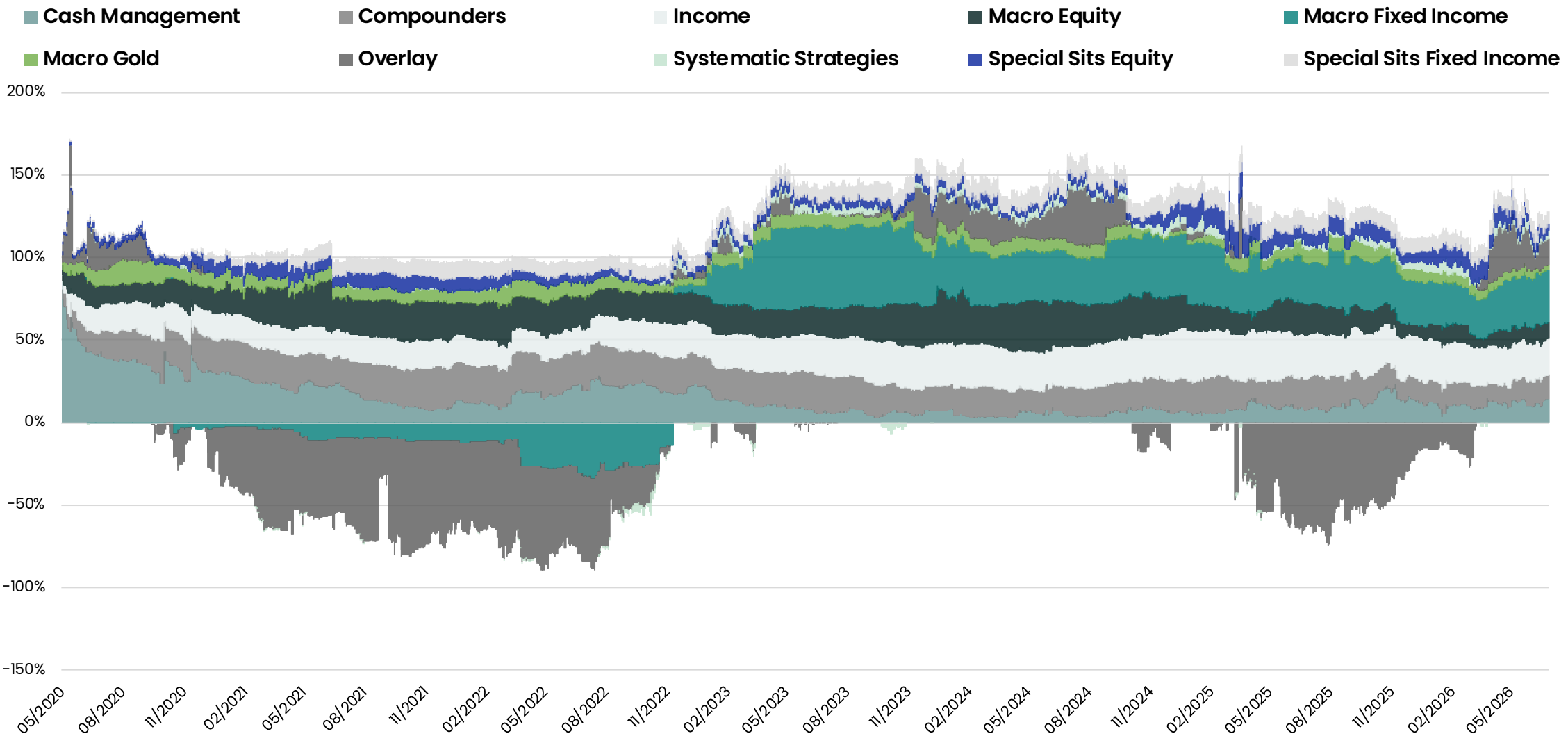

Strategy Allocation Evolution

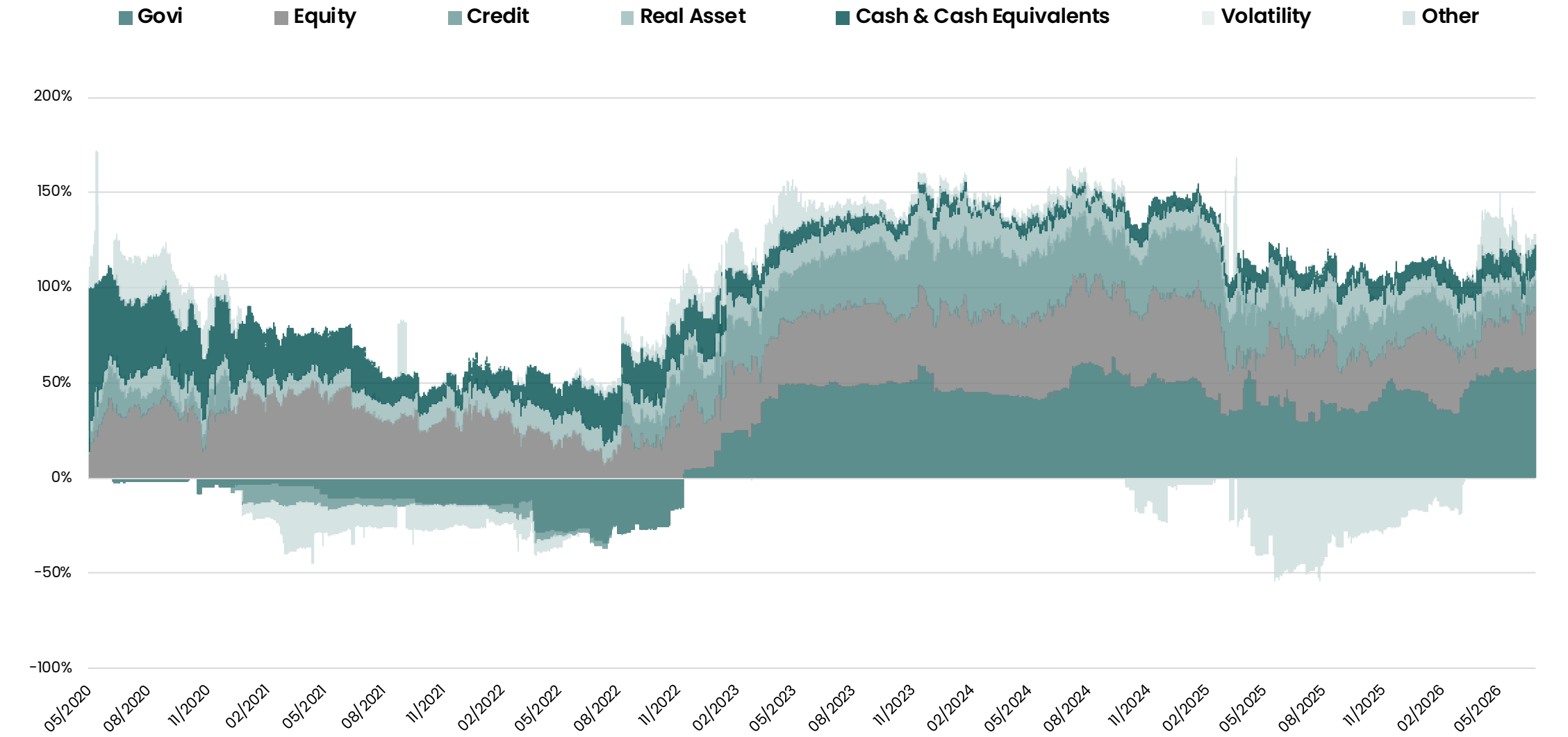
Delta-Adjusted Exposure

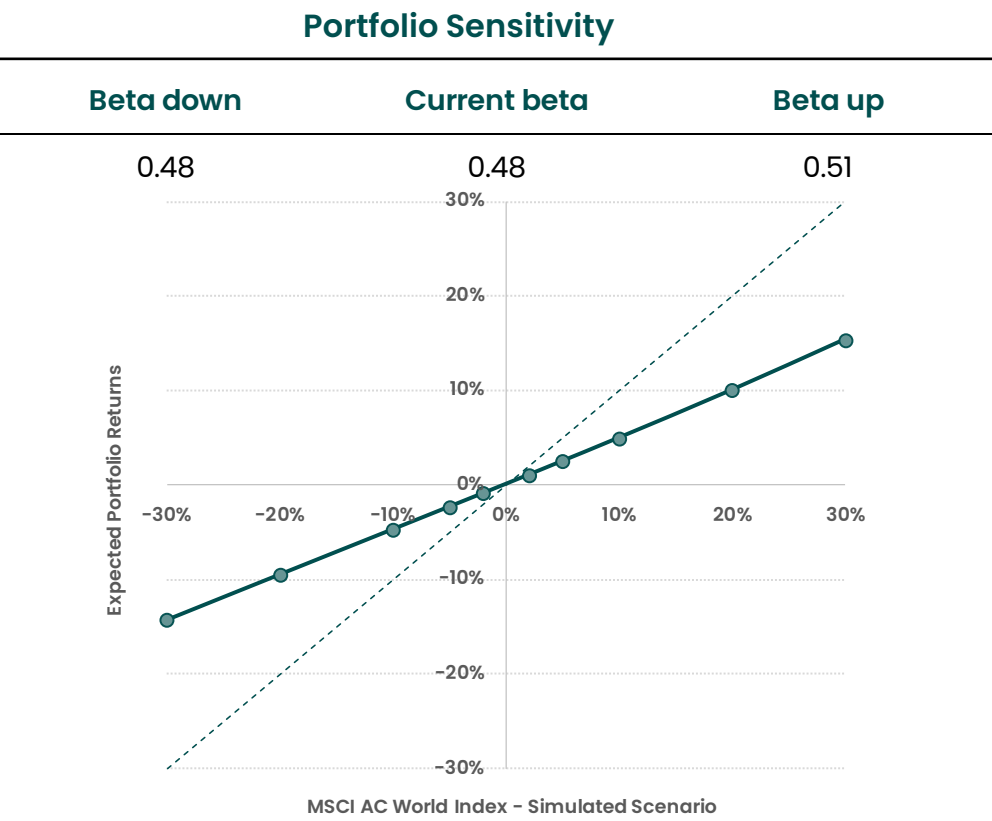
Asset Class Allocation Evolution

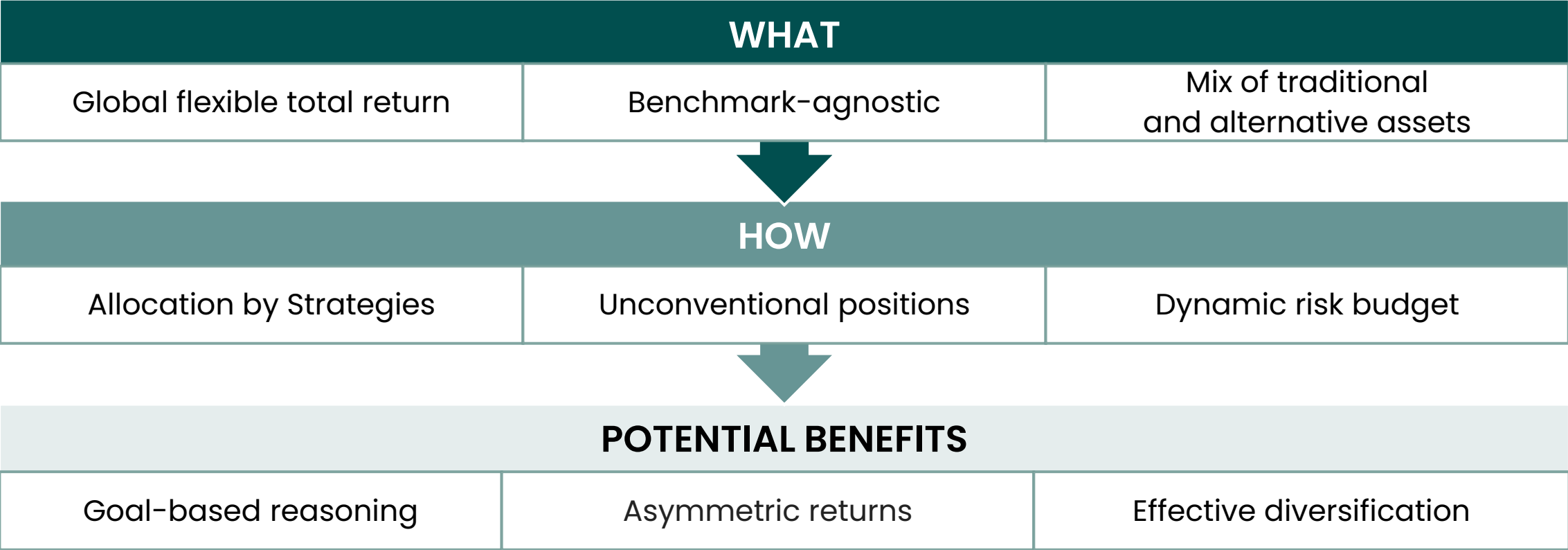

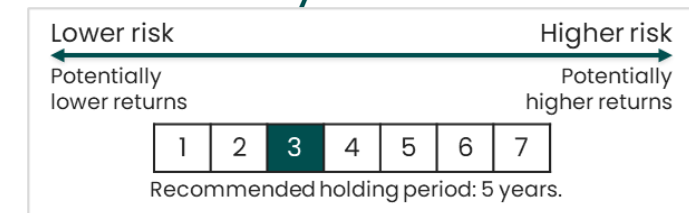
